### CANCEL EWB+IRN API

To access the API, the application should first authenticate using the credentials shared. The API content information is used for authentication and authorization purposes.

This API is useful if there is a need to cancel both EWB and E-invoice.

Remark- As per government, there are two separate JSON to Cancel EWB and E-invoice and sequence of cancellation is first EWB (if Exists) and then E-invoice, however we have created one JSON containing Both EWB and IRN Number and we will manage the communicating with of Respective GOV API internally. Also we have handled cancellation of multiple documents in one JSON. Hence it is an array (list).

As a result, if you have only one EWB and IRN to be cancelled even in that case, we request you to send data in array only.

The format and details of cancelling E-Way Billl API request are depicted in the following table:

### VALIDATIONS

- 3. E-way bill can be cancelled by the generator of the e-way bill only.
- 4. E-way bill can be cancelled within 24 hours of generation of e-way bill 5. Einvoice cannot be canceled, if the Valid/Active E-way Bill exists for the same.
- 6. IRN Can be cancelled within 24 hours of IRN Generation.
